Cornell University requires all international students, regardless of visa type, to certify sufficient funds to cover tuition and living expenses for the minimum duration of the degree program. This documentation is required of all students prior to official admission. If you intend to come to the United States on an F1 or J1 Student Visa to attend Cornell University you must provide certification of funds in order to receive the Certificate of Eligibility (Form I-20 or DS-2019) which allows you to apply for the visa. If you will have an F-1 or J-1 visa and dependents will accompany you to the United States, you must also provide certification of funding for their living expenses.

You must complete and return this Financial Responsibility Form with required supporting documents within 30 days of receiving this form. Award letters or bank statements not accompanied by this form will not be accepted. **PLEASE READ AND FOLLOW DIRECTIONS FULLY.** Incomplete or incorrect forms will delay or prevent the issuance of a visa certificate.
